





Making services fit for people: Inspiration for change





Charlie McMillan

Charlie McMillan is the Interim Director of the Human Rights Consortium Scotland which is Scotland's civil society network organisation and a human rights defender which promotes human rights awareness, compliance and incorporation.

Charlie trained as a social worker and has worked in wide range of roles supporting people on the margins of society including alternatives to custody, HIV/AIDS support and advocacy, mental health support and provision of support services for disabled people. Other than three years with the Scottish Government, he has worked in the Scottish voluntary/charity sector throughout his career.

Charlie joined the Human Rights Consortium in September 2024. He is co-chair of the Scottish National Action Plan for Human Rights Leadership Panel (SNAP 2). Previously, he founded and was Chair of Restraint Reduction Scotland, and the Scottish Gender-Based Violence and Learning Disability Steering Group. Charlie has experience in designing and delivering support services, lobbying, campaigning, policy development and is an advocate for participation and co-production. He is Chair of the Board of Trustees for Dates'n'Mates Scotland which supports people with learning disabilities to develop friendships and relationships and Chair of the Global Leadership Exchange's Advisory Group for Disability. Charlie is an individual LGBT+ activist and has a wide range of other personal interests including a mindfulness-based



meditation practice.

Phil Wilshire has been a mental health social worker for 28 years and an ASW/AMHP for 25. He has managed a variety of community mental health teams in the South-West and was the Social Work and Social Care Lead for Avon and Wiltshire Mental Health Trust from 2014 to 2022.

He was on the committee of the mental health streams of work both for the short-lived College of Social Work and BASW and has organised conferences for the Social Care Strategic Network (SCSN) and for the Movement for Social Approaches in Mental Health.

He was Social Work and Social Care advisor to the BPS Division of Clinical Psychology "Power Three Meaning" Project and has been involved in teaching the approach in various forums. Currently he is the "Head of Care Planning Transformation" for AWP and is part of a team working locally to support care planning to be more personalised.









Iona Colvin

Chief Adviser to Scottish Ministers, responsible for advising on social work and care policy across adult, children, families, and justice sectors.

Led the development of the National Social Work Agency (NSWA) and contributed to the Care Reform Bill and to the establishment of the Social Work Education Partnership and served as sponsor for the Scottish Social Services Council.

A former Director of Social Work and Chief Officer for North Ayrshire Health and Social Care Partnership where she oversaw integrated services across health and social care, including mental health for NHS Ayrshire and Arran.

Iona worked 27 years in Glasgow City, including as Community Health Care Director for South West Glasgow. Iona was the first joint general manager for addiction services city-wide, developing integrated models for drug and alcohol treatment.

Iona is an Honorary Professor of Social Work at Edinburgh University and has recently received an OBE for services to social work.

Dr Jane Shears


National Director, Scottish Association of Social Workers & British Association of Social Workers NI

Advisory Member of SASW's National Committee




An expert by experience, Linda is disabled and has employed a wonderful PA for about 17 years. At age 75, she has a sight impairment and a few other health issues.

Susan Dobson




Susan Dobson is a registered social worker and Professional Officer with SASW. She has over 20 years experience working in child protection in the public and third sectors.

He has held full or honorary professorships at five UK universities and is currently a visiting professor at the Open University and Wrexham University.



Claire Longmuir


Director of Operations, The Simon Community

Alison has spent 30 years working in the NHS in Scotland, mostly in various Public Health roles. Her current position is Associate Director of Public Health with NHS Highland. In 2010, she returned to her hometown of Campbeltown giving her the opportunity to bring up her family in a tight knit rural community with extended friends and family close by.

Public Health is about improving health and wellbeing outcomes for the whole population and Alison's passion is what keeps people well and able to live a good life. Professor Sir John Curtice


Professor of Politics at the University of Strathclyde, and Senior Research Fellow, National/Scottish Centre for Social Research and the ESRC's 'The UK in a Changing Europe' initiative

He has written extensively about voting behaviour in elections and referendums in the UK, as well as on Scottish and British political and social attitudes more generally.

He has been a co-editor of the National Centre's annual British Social Attitudes reports series for over thirty years, a co-director of the Scottish Social Attitudes series since 1999, and is a regular contributor to Scottish, British and international media coverage of politics in the UK.

Curtice is Chief Commentator at two websites, whatscotlandthinks.org and whatukthinks.org/eu, that provide a comprehensive collection of materials on public attitudes towards (i) how Scotland should be governed, and (ii) the UK's relationship with the EU.

He is a Fellow of the British Academy, the Royal Society of Edinburgh, the Academy of the Social Sciences, and the Political Studies Association. He is also an Honorary Fellow of the Royal Statistical Society and the Market Research Society.









John Dickie

Director of the Child Poverty Action Group (CPAG) in Scotland

John is responsible for promoting and influencing policies that will contribute to eradicating child poverty in Scotland. He was previously Head of the Youth Unit at Scottish Council for Single Homeless. Before that he worked directly with young people experiencing homelessness, both as a volunteer and professional.

He is a graduate from Aberdeen University in Sociology and Social Anthropology, and holds a postgraduate diploma in Housing Studies from Stirling University. He lives in Edinburgh and enjoys spending time with his family, walking and cycling among other things.



General Secretary of the Social Workers Union


John served on the UK Council for BASW as a Non-Executive Director (2008–2012) and on SASW's Executive Committee as Depute Convenor. He was elected as General Secretary of the Social Workers Union in 2016 and re-elected unopposed in 2021. This year, he became Vice President of the General Federation of Trade Unions (600,000 members) and currently sits on its National Executive Committee.

John is Programme Tutor for the Open University Social Work Degree in Scotland and previously served its UK Council. He now sits on its UK Board of Studies. Since qualifying as a social worker in the 1990s John has predominately worked in the field of Children and Families, Fostering and Adoption and as a training officer/ practice teacher. John is proud of his working-class upbringing in a housing estate in Edinburgh regarded as one of the most deprived areas in Scotland. His parents were active foster carers, fostering over 100 children in total.

He has contributed widely to UK Parliament forums, presentations, media, publications, journals, and ongoing research and co-authored (with Dr Neil Thompson) the published JKP book ' How to Survive in Social Work'.

John also served as a professional consultant for the Ken Loach movie 'Sorry I missed you'.

Monica Lennon is a Scottish Labour and Co-operative Member of the Scottish Parliament for Central Scotland, first elected in 2016.




